Otsuka OPV, the Vietnamese subsidiary of Otsuka Pharmaceutical Factory announces the construction of a new factory for the distribution of high quality IV solution products

Otsuka Pharmaceutical Factory, Inc. (OPF) has announced that its subsidiary in Vietnam, Otsuka OPV Joint Stock Company (OOPV) will commence the construction of a new factory, compliant to PIC/S*¹ GMP*² standards.

OOPV was established in 2003, and is currently operated by OPF, Otsuka Pharmaceutical Co., Ltd. and Nomura Trading Co., Ltd. as a joint venture company. OOPV manufactures and distributes IV solution products such as basic IV solution products and highly concentrated amino acid IV solution products. Additionally OOPV imports and distributes medical food products. OOPV has made a decision to construct the new factory with expanded production capacity that is compliant to PIC/S GMP, a global standard, in order to better serve more number of patients with high quality IV solution products. The products manufactured in the new factory will be distributed in Vietnam and neighboring countries with a view to expand distribution in the future.

OOPV has also decided to change the corporate name to Otsuka Pharmaceutical Vietnam Joint Stock Company. The name will officially change once the application for name change is submitted and approved.

The Otsuka Group started its overseas operation of IV infusion product business in the 1970s, and currently operates 15 companies centering around the Asian region, distributing products to approximately 75 countries worldwide.

Based on the corporate philosophy of "Otsuka-people creating new products for better health worldwide", the Otsuka group of companies is dedicated to contributing to the health of people around the world.

^{*}¹ Pharmaceutical Inspection Convention and Pharmaceutical Inspection Co-operation Scheme is a non-binding, informal co-operative arrangement between regulatory authorities in the field of Good Manufacturing Practice (GMP) of medicinal products. Established in 1970, PIC/S is currently comprised of 49 participating authorities worldwide. Japan has been a member since 2014.
